Please note that all riders are secured to the Zamboni seat by a seat belt.

We, the parent(s) or guardian(s) of _____ /I agree to the following:

1. We agree that we are allowing our child to ride/that I am riding the Zamboni of our/my free will and on a voluntary basis.
2. We understand that we do not have to allow our child to ride/that I do not have to ride the Zamboni if we/I do not wish to do so.
3. We understand that risk of physical injury, partial or total disability, paralysis, death and/or property damage exists while riding the Zamboni.
4. We agree that if we allow our child to ride the Zamboni/I ride the Zamboni, we/I accept all responsibility and all risk of physical injury, partial or total disability, paralysis, death or property damage that may occur as a result of our child/my riding the Zamboni.
5. We understand that these risks may be caused by our child's/my own negligence or the negligence of others. It is further acknowledged that there may be risks and dangers not known to Roseville Sportworld, Inc., or that are not reasonably foreseeable at this time.
6. We agree to waive all rights to any and all legal action against Roseville Sportworld, Inc. and its shareholders, directors, officers, employees, instructors, contractors, agents, and affiliated entities/companies (collectively "Releasees") related to any personal injury, partial or total disability, paralysis, death or property damage arising out of or related to riding the Zamboni whether based in tort, contract or statute and release Releasees from all liability re same. This waiver and release also extends to any event hosts, other participants, coaches, officials, sponsors, advertisers, owners and operators of the premises used to conduct any event and each of their officers, directors, agents and employees.
7. We agree if any claim for personal injury or wrongful death is commenced against Releasees, we shall defend, indemnify and hold harmless Releasees from all claims or causes of action by whomever, wherever made or presented for our child's or my personal injuries, property damage or wrongful death.
8. Rider and Rider's parent(s)/guardian(s) agree not to sue Releasees to recover for personal injuries, property loss/damage or death arising out of or related to riding the Zamboni.
9. Rider understands that they must sit only in the passenger seat and wear their seat belt at all times. Rider must not climb on or off the Zamboni without the assistance of the Zamboni driver.
10. We/I have read the above and agree to be bound by the terms and conditions above.
